| 9. Are the harness straps worn, frayed, been washed in a washing machine, or punctured by a safety pin or tagging gun needle? | Yes - Destroy Seat or obtain replacements, then continue | No - Continue |
| 10. Has the car seat been checked for a flight? | Yes - Destroy Seat | No - Continue |

| 11. Does the seat have all parts including harness straps, harness clip, seat cover, tether, padding, shield and bolts? | Yes – Continue | No – Destroy Seat or obtain replacements, then continue |
| 12. When buckled, does the mechanism lock securely and remain locked when in use? | Yes - Continue | No – Destroy Seat or obtain replacements, then continue |
| 13. Are there any items with the carseat that are considered after market or were not sold originally with the seat? | Yes - Remove items before selling | No - Continue |

| 14. Have the car seat and/or straps been cleaned only per the manufacturer's instructions? | Yes – Continue | No – Destroy Seat or contact manufacturer to verify integrity hasn't been compromised, then continue |
| 15. Have you hosed down the carseat or carseat base? | Yes - Destroy Car Seat | No - Continue |
| 16. Is the seat clean with no visible stains, holes, or tears? | Yes - Continue | No - Clean and repair or Destroy Seat |
